Household Financial Savings And Liabilities In India: RBI's Assessment. Source: Mint

- The Reserve Bank of India (RBI) released its latest Financial Stability Report (FSR), revealing insights into the state of household financial savings and liabilities in the fiscal year 2022-23 (FY23).
- Despite a decline in gross household financial savings to 10.9% of GDP, the report emphasizes a limited risk of defaults by households, attributing it to the manageable exposure to higher mortgage payments and floating interest rates.
- The FSR notes a significant increase in household financial liabilities, rising from 3.8% of GDP in FY22 to 5.8% in FY23.
- This surge, driven by increased borrowings for physical asset creation, primarily in mortgages and vehicles, contrasts with a marginal moderation in financial assets to 10.9% in FY23 from 11.1% in FY22.

Rajasthan Seeks Integration Of Chiranjeevi Scheme With Ayushman Bharat. Source: Mint

- The newly elected BJP government in Rajasthan is making strides to merge its state health insurance scheme, Chiranjeevi, with the central Ayushman Bharat programme.
- This move, pending approval from the union health ministry, aims to create a unified initiative called the Ayushman Bharat Mukhyamantri Chiranjeevi Health Insurance Scheme.
- Officials reveal that the integrated scheme will maintain Chiranjeevi's existing benefits, providing a substantial ₹25 lakh insurance cover applicable to both private and government hospitals.
- The Chiranjeevi scheme, initially introduced by former Chief Minister Ashok Gehlot of the Congress party, currently offers significantly higher coverage compared to Ayushman Bharat's ₹5 lakh.

Tamil Nadu Fast Reactor Plant Inaugurated by Prime Minister with an investment of Rs 400 crore Source: Narendra Modi

- Dedicating it to the nation, Prime Minister Narendra Modi unveiled the Demonstration Fast Reactor Fuel Reprocessing Plant (DFRP) at the Indira Gandhi Centre for Atomic Research (IGCAR), Kalpakkam, with a cost of Rs 400 crore.
- The DFRP boasts a unique design, crafted entirely by Indian scientists. This facility is capable of reprocessing both carbide and oxide fuels discharged from fast reactors, setting it apart as the only one of its kind globally.
- This facility is a significant step towards advancing India's nuclear capabilities, designed to reprocess fuel from Prototype Fast Breeder Reactors (PFBR).
- The fast reactor power generation company, Bharatiya Nabhikiya Vidyut Nigam Ltd (BHAVINI), based in Kalpakkam, is at the forefront of this initiative.

- The anticipated peak production from the 98/2 field is remarkable, with expectations set at around 45,000 barrels of oil per day and over 10 Million Metric Standard Cubic Metres per Day (MMSCMD) of gas.
- As the project advances, ONGC is actively working towards the final phase of the 98/2 block, with efforts underway to commence the production of the remaining oil and natural gas by mid-2024.

- Despite earlier expectations for the Executive Board's approval in December, the decision has been deferred to January 11, as a Staff-Level Agreement between the IMF staff and Pakistani authorities awaits the Board's approval. The potential approval holds significance for Pakistan's economy, providing crucial financial support.
- Discussions between the IMF staff and Pakistani authorities continue regarding policies aimed at bolstering macroeconomic stability in the upcoming year. The IMF noted progress over the FY23 budget, but the latest economic projections for Pakistan reveal a challenging outlook for 2024. The report added that the IMF predicts a contraction of 0.5% in the real GDP for the year and a significant increase in the Consumer Price Index, suggesting heightened inflationary pressures.

India is one of our closest neighbours and allies. - Over 2 lakh Indians visited Maldives annually in the last three years, the highest from any country post-COVID 19 pandemic, according to the official data, reported PTI, amid calls from several quarters to boycott the island nation as a travel destination following a diplomatic row between the two nations.
- According to the Maldives Tourism Ministry statistics, over 17 lakh tourists visited the island nation in 2023, out of which more than 2,09,198 visitors were Indians followed by Russians (2,09,146) and China (1,87,118).
- The number of Indian visitors was more than 2.4 lakh in 2022 while over 2.11 lakh Indians flew to the Maldives in 2021. The Maldives was also one of the few countries open for international tourists during the pandemic and nearly 63,000 Indians visited that country during that period.

- Of the 346 members of parliament who voted, 287 were in favor of Sweden's accession and 55 voted to reject it. Four others abstained from voting.





- The vote was the second step of Turkey's ratification process after the parliament's Foreign Affairs Commission approved the bid last month. Turkish President Recep Tayyip Erdogan can now sign the protocol into law.
- The outcome on Tuesday cleared a significant hurdle for the Nordic country's accession into the military alliance, with Hungary now set to be the only member state that has not yet ratified Sweden's accession.





It's very hard to compare the Test matches that you play because every Test match has its own importance and own relevance. The Test match that we won at The Gabba as well. The last test match that was lost by Australia in Brisbane was in 1988, I think. Nearly after 23, 24 years (32 years), we won the Test match there. It kind of became like their fortress. They never lose a test match there," Rohit said
- "And the way we won that Test match as well was quite important. From where we came, we were 1-nil down, we won in Melbourne and then we drew the Test match in Sydney and then won in Brisbane. So you can't really rank the Test matches, but this has to be right up there because we had not won here. That shows how important a venue this is for us to come here and perform. I give a lot of credit to our team to put up a performance like that and win the game," the India captain said.

- India's GST collections rose 10.28 percent to reach Rs 1.65 lakh crore in December, the Finance Ministry announced today. The Goods and Services Tax (GST) mop-up was nearly Rs 1.50 lakh crore in December 2022. The December 2023 collections are, however, lower than Rs1.68 lakh crore collected in November and even down from Rs 1.72 lakh crore mopped up in October, which was the second-highest collection ever since the GST rollout.



- "During the month, the revenues from domestic transactions (including import of services) are 13% higher than the revenues from these sources during the same month last year," the finance ministry said in a statement.
- The average gross monthly GST collection in the FY 2023-24 now stands at Rs. 1.66 lakh crore and is 11% per cent more than that in the same period in the previous financial year," the finance ministry said in a statement.
- "The remarkable growth in GST collections over the past few months is not only on account of the underlying strong economic factors, but also due to the efforts of the tax authorities in deploying tools to compare data sets to determine short payment and evasion," MS Mani, partner, Deloitte said.
- "The growing emphasis on audits led by specific information available on various databases, not only on the GST portal, has led to a significant increase in compliance across sectors and states," Mani added.
